GUIDELINES, STANDARDS AND RESTRICTIONS (GSR)

Declaration of Covenants & Restrictions for Hammock Reserve.

Article VIII – The Association shall at all times be responsible for the normal and routine painting of the exterior walls and fences of the Units. Each Owner shall maintain his or her own Unit and structures, driveway, walkways/sidewalks and other improvements in good condition and repair and in like condition, appearance and quality as originally constructed. The Association shall be responsible for normal and routine pressure cleaning, painting, and refinishing of the exterior walls and fences of a Unit. The Board shall determine the need for such cleaning and painting from time to time. No Unit Owner shall authorize the painting, refurbishing or modification of the exterior surfaces of his Unit or of the Unit building. Normal maintenance of the exterior surfaces, such as pressure cleaning, repainting and refinishing, shall be done uniformly at the same time for the entire Unit building by the Association and as an Association Expense.

Article XII – The ACC shall regulate the external appearance, use, and maintenance of the General Plan of Development and of improvements thereon in such a manner as to comply with and meet the Community-Wide Standard, to best preserve and enhance values and to maintain a harmonious relationship among structures and the natural vegetation and topography. No construction of improvements (including without limitation, paint or stain color) is permitted, and all proposed exterior colors and/or finishes must be approved by the ACC, its successors or assigns.

Property Owners are NOT ALLOWED to paint or change their driveway. Property Owners are NOT ALLOWED to paint or change Hammock Reserve HOA common area apron/driveway or sidewalks.

All approved colors within Hammock Reserve HOA, as listed within this GSR, are available at *Sherwin Williams* locations; appropriate color codes are provided in this GSR. The local Sherwin Williams location nearest Hammock Reserve is Sherwin Williams, 5869 W Atlantic Ave Ste A1, Delray Beach, FL 33484; (561) 496-1717.

A. Common Wall Color:

1. White Duck – SW7010

B. Entrance Gates and Street Signs Color:

1. Urbane Bronze – SW7048

C. House Colors (Exterior Walls) Colors:

1. White Duck – SW7010
2. Pure White – SW7005
3. Origami White – SW7636
4. City Loft – SW7631

D. Front Door Colors:

1. White Duck – SW7010
2. Contented – SW6191
3. Tricorn Black – SW6258
4. Smoky Azurite – SW9148
5. Waterloo – SW9141
6. Pure White – SW7005

***Front door color MUST match house shutter color, *except* any Unit may have a front door color of Pure White (SW7005) regardless of shutter color.**

E. House Trim, Soffits, and Garage Door:

1. Pure White – SW7005

F. Downspouts and Gutters Color:

1. Pure White – SW7005

G. Walkways (around the house) Color:

1. White Duck – SW7010

H. Louvered Vinyl Exterior Shutters:

1. White Duck – SW7010
2. Contented – SW6191
3. Tricorn Black – SW6258
4. Smoky Azurite – SW9148
5. Waterloo – SW9141
6. Pure White – SW7005

I. House Bahama Shutters/2" Low Profile Decorative Bahama Shutter (must color match Sherwin Williams paint colors below):

1. White Duck – SW7010
2. Contented – SW6191
3. Tricorn Black – SW6258
4. Smoky Azurite – SW9148
5. Waterloo – SW9141
6. Pure White – SW7005

The location of the Bahama shutters must be approved by the Architectural Control Committee (ACC) prior to installation.

J. Fabric Awnings:

1. White
2. Black

K. Soffit Vent Covers:

Home Depot: Master Flow High impact resin soffit white oval (4 x 12 inch)

L. House Numbers:

4" Black Fancy Numbers
